Background

Historically, the South Asian region constitutes an extended cultural zone which has contributed tremendously in practically all fields of human endeavour. Its pluralistic, multi-layered and often overlapping ethos is manifested in the region's dresses, cuisine. customs, religions, traditions, rituals, languages, scripts and many other socio-cultural spheres, all unfolding within a greater cultural space. The region has served both as a melting pot as well as a fulcrum for the circulation of men and goods, ideas and cultures, money and material across the globe and today it boasts of the largest share in world's diasporic population. This itinerant populace of South Asia have also served as the unnamed and unsung cultural ambassadors, not only within the region but also across the globe.

- What causes and precipitates circulation of ideas and cultures, and diaspora formation?
- What restricts the circulation of cultures and what promotes it? What are the barriers and filters? What are the dynamics of the diaspora?
- How is this circulation driven by global as well as local, regional. and national cultural and intellectual currents?
- How does the circulation of cultures contribute to the strengthening (in some cases subsuming or metamorphosing) of local cultures and traditions as well as cross-fertilization?

These are some of the questions that the proposed research project will seek to address through a series of studies focussing on the history of circulation of the South Asian cultures during the last three centuries, which was a period of great political turmoil in the region. It saw both the consolidation as well as collapse of a number of colonial powers and also the fructification of liberal and democratic aspirations of its people. This period also witnessed an unprecedented surge in the migration of South Asian workers to other colonial settlements across the globe. All these factors influenced and shaped the diasporic cultures of the region.

Thus through specific examples and research on ethnicity and immigration the proposed research project will analyse various aspects of the historicity of cultural circulation, the role of geopolitical factors in shaping it, and also in terms of the ownership of ideas.

The Project will address issues within three broad themes, viz.:

- Circulation of South Asian Peoples and Commodities:
- Circulation of Ideas and Cultural Expressions; and
- Monetary and Trade Networks

(within and outside the South Asian region).

Research Programme

This Programme has the following two steps:

- SAARC Regional Conference on 'Circulation of Cultures and Culture of Circulation: Diasporic Cultures of South Asia during 18th to 20th Centuries' to identify themes and subthemes for the research projects, and
- Research Projects on Diasporic Cultures of South Asia during 18th to 20th Centuries that will be conducted by researchers from SAARC member States.

SAARC Regional Conference on 'Circulation of Cultures and **Culture of Circulation: Diasporic Cultures of South Asia during** 18th to 20th Centuries'

Introduction

SAARC Regional Conference on 'Circulation of Cultures and Culture of Circulation: Diasporic Cultures of South Asia during 18th to 20th Centuries' will be a brainstorming session to discuss the key issues and moot research questions and also to identify themes and subthemes of diasporic cultures of South Asia that merit independent and in-depth research. Academics and experts on the subject are invited for the Conference to present papers on a relevant theme.

Objectives Of The Regional Conference

- To identify the diasporic cultures of the Region;
- To discuss the country situation (of the SAARC Member States) related to diasporic cultures;
- To identify research topics and guestions related to diasporic cultures in the Region that need further investigation: and
- To recognize research approaches and methods for further research in diasporic cultures of the region.

Dates And Venue

The SAARC Regional Conference on Diasporic Cultures will be held in Galle, Sri Lanka for 3 days from 15 to 17 March 2012.

Post-conference Tour

One day Post-Conference tour will be organized on 18 March 2012 to Katargama, for all registered delegates of the Conference. Katargama is one of the leading historical places where multi-ethnic and multi-religious involvement could be seen in Sri Lanka.



Official Nominees From The Member States:

The SAARC Cultural Centre invites all the Member States to send a minimum of three nominations (maximum 10 persons can be nominated by a Member State) from amongst the experts and academicians of their country.

Accompanying Persons:

Every person accompanying the official nominees of the SAARC Member States (viz. the Delegates/ Resource Persons-cum-Panel Heads) should pay a registration fee of US \$ 300/- towards his/her boarding and lodging during the Conference. All such accompanying persons will be accommodated with the respective official nominee on full board/twin-sharing basis.

Other Participants:

The SAARC Cultural Centre would also accept the participation of other experts from the region (other than the nominees of the respective SAARC Member States) as well as from those residing outside the SAARC Region provided they are able to meet their travel and accommodation expenses to attend the Conference. However, to facilitate their stay during the Conference, the SAARC Cultural Centre would assist them in securing accommodation in guest houses/ hostels at economic/subsided rates.

The last date for sending the nominations/ registration forms is 20 February 2012.


